### Illawarra-Shoalhaven City Deal Advocacy kicks goals with 8% of funding achieved













The Illawarra-Shoalhaven City Deal Prospectus was launched by the 4 Mayors and Chair of RDA Illawarra on 16 October 2020.

Since the launch, we have continued our advocacy by disseminating the prospectus to >100 stakeholders and holding >30 meetings with stakeholders outside of the region including federal and state governments.

We are tracking funding progress through a barometer, and have so far **secured \$69.2m** in funding across 3 City Deal projects – or 8% of the total funding sought - a great achievement in a short 6 week period!

### **Leadership Illawarra Program** secures 27 participants for 2021-2022 cohort

#### 9<sup>th</sup> Year running – 27 participants

In December 2020, the 2018-20 Leadership Illawarra Program (LIP) cohort rounded out their 2+ year program and the next cohort (9<sup>th</sup> year running) recruitment concluded.

The 2018-20 cohort finished their program with 21 participants graduating at the TIC dinner meeting in December.

The incoming cohort (2021-22) were selected:

- 34 EOI's, with 27 successful candidates accepted
- 4 scholarship winners congratulated:

  - Hayley Rodd Colliers International Wollongong
  - Robyn Dawson Sustainable Buildings Research Centre

This cohort of 27 participants is the largest to date, highlighting the success and growth of the LIP program.





### Thought-provoking new remote work models discussed at RDA Illawarra Future of Work Roundtable

On 29 October, RDA Illawarra hosted a round table event which kicked off the Future of Work project. Three inspiring leaders were called upon to speak at the webinar:

- **Craig Osborne:** Managing Partner of RMB Lawyers, Director of Unison Outsourcing (and RDA Illawarra board member)
- **Greg Doyle:** General Manager of Wollongong City Council, (and RDA Illawarra board member) and

**45 people** attended the webinar, and the discussion was focused on our experiences of remote working (Fad vs Future), the challenges and opportunities for managing employees, and the regional development and commercial risks, models and opportunities.

The Future of Work round table was a great way to share insights, expertise and the future opportunities that remote work models will bring to the Illawarra region.
